The Lawnside Historical Society is excited to partner in this effort and applauds the quick progress. The Society's board of directors is supportive of Option 2 closer to the community center. The board is willing to help defray the cost of installing the solar lighting system there as outlined in Mr. Smith's April 20 email message. That is two solar lights at an approximate cost of \$1,750 - \$2,000 including installation LED 150W- approximately 2100 lumens with motion sensor. Our objections to Option 1 cite its proximity to the abandoned, disheveled house and limited space in front of the drainage basin. Option 3, while nearer the streetlight at Walter Gaines Way, is similarly less desirable. Again, thanks so much for this extraordinary opportunity."
