Pursuant to Lawnside Code Book Chapter 102 – 2B. The owner of any newly acquired business shall submit Mercantile License Application to the Borough Clerk upon Zoning Permit Approval and a Passing Certificate of Occupancy Inspection. No business operations can initiate without issuance of a mercantile license.

Pursuant to Lawnside Code Book Chapter 102-3. All business owners shall pay the required annual mercantile license fees annually by January 30th of each year. Any business owner who does not pay the required annual mercantile license fees by January 30th shall be assessed a late fee of \$50 at the time of application. Mercantile License shall expire on December 31st of the licensing year. Any business owner found to be transacting business without the required license is subject to cease of business operations until the business is in compliant and required fees are received by the Borough Clerk and subject to a fine of \$100 per day for violation of the terms aforementioned in Chapter 102.

Pursuant to Lawnside Code Book Chapter 103-3. The Borough of Lawnside shall deny the issuance, reissuance or renewal of any license or permit to any person, licensee, permit holder, or applicant who owes delinquent property taxes or any other delinquent assessment in the Borough of Lawnside.
