Further, the public officer delegated the responsibility for delivery of the copies to said libraries has completed a certification forwarded to the governing body that such deliveries were made and copies have been made available by the Clerk to persons requesting them; and

**WHEREAS**, these two conditions have been met.


**NOW, THEREFORE, BE IT RESOLVED** that the budget shall be read by title only.



FOR THE BOROUGH OF LAWNSIDE POLICE DEPARTMENT**

**WHEREAS**, Mayor and Council of the Borough of Lawnside, County of Camden and State of New Jersey are charged with protecting the health and safety of its citizens; and


**WHEREAS**, the Mayor and Council, through its Public Safety Committee, have determined that the Police Department is in need of a full-time Police Officer Patrolman I; and

**WHEREAS**, Lamar Ransome is certified by the Police Training Commission and is available to be hired as a full-time Police Officer Patrol I required by required by N.J.S.40A:14-122 and by 23 the New Jersey Police Training Commission.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Lawnside, County of Camden, State of New Jersey, that:

1. Lamar Ransome be hired as Police Officer (Patrolman I) effective August 5, 2020 at a salary of \$54,573.00 as per the collective bargaining agreement between the Borough of Lawnside and PBA Local #30;
2. Lamar Ransome will be eligible for membership in the Police Benevolent Association Intercounties Local #30 (PBA Local #30), and all of the benefits which inhere to full time members of the Lawnside Police Department who are governed by the terms and conditions of the collective bargaining agreement between the Borough of Lawnside and PBA Local #30;
