RESOLUTION APPOINTING A FIRE CHIEF FOR THE BOROUGH OF LAWNSIDE

WHEREAS, the Mayor and Council of the Borough of Lawnside, have the authority to adopt resolutions and to promulgate rules and regulations that pertain to its government and affairs and protect the public health, safety and welfare of its citizens; and

WHEREAS, the Lawnside Volunteer Fire Company does not presently have a Fire Chief and the Governing Body have determined that it is in the best interest of the Borough of Lawnside and its citizens to appoint a Fire Chief to manage the Department; and

WHEREAS, the Governing Body have determined that Timothy Drumm II possesses all qualifications and experience necessary to fully and satisfactorily perform all functions as Fire Chief; and

WHEREAS, Timothy Drumm II has expressed a desire and willingness to be bound to perform thereunder; and

WHEREAS, the Mayor and Council of the Borough of Lawnside desire to appoint **Timothy Drumm** II as the Fire Chief for the remainder of the 2022 Calendar Year (N.J.S.A. 40A:14-68).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Lawnside, County of Camden and State of New Jersey, that **Timothy Drumm II** is appointed as the Fire Chief for the Borough of Lawnside, effective July 13, 2022 and expiring December 31, 2022, at a rate per the salary ordinance.
