
**RESOLUTION AUTHORIZING THE HIRING OF TWO PART TIME LABORERS IN

Part time laborers are limited to a maximum of (30) work hours per week. Upon successful completed of 90 days an evaluation will be made to determine if eligible for full time status.

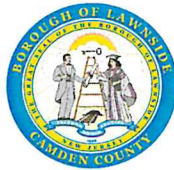

Approval to submit a grant application and execute a grant contract with the New Jersey Department of Transportation for the Lundy Avenue Resurfacing Project.


NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of Lawnside formally approves the grant application for the above stated Project.

HOMEOWNERS WHO REDEEM MUNICIPAL LIENS – BLOCK 904 LOT 14**


WHEREAS, the Municipality collects prior year charges from homeowners for Camden County Municipal Utilities Authority; and

His advice, guidance, and ministering to the communities he served;


His devout work as A Civil Rights Activist and faithful military service in the US Air Force.
