WHEREAS, the Tax office has made numerous attempts to reach homeowners to complete redemption unfortunately without success.




**RESOLUTION GRANTING A TOTALLY DISABLED




**RESOLUTION GRANTING A TOTALLY DISABLED




**RESOLUTION AUTHORIZING


WHEREAS, Mayor and Council of The Borough of Lawnside desire to continue the regular and efficient operation of The Borough Offices; and


RESOLUTION AUTHORIZING REFUND FOR 2022 BUSINESS LICENSE OVERPAYMENT





WHEREAS, Mayor and Council of the Borough of Lawnside, County of Camden and State of New Jersey are charged with protecting the health and safety of its citizens; and


WHEREAS, the Mayor and Council, through its Public Safety Committee, have determined that the Police Department is in need of a full-time Police Officer Patrolman I; and

POLICE RECRUIT OFFICER IN THE BOROUGH OF LAWNSIDE**


WHEREAS, Mayor and Council of the Borough of Lawnside, County of Camden and State of New Jersey are charged with protecting the health and safety of its citizens; and
