WHEREAS, Mayor and Council of the Borough of Lawnside, County of Camden and State of New Jersey are charged with protecting the health and safety of its citizens; and

WHEREAS, the Mayor and Council, through its Public Safety Committee, have determined that the Police Department is in need of a full-time Probation Police Officer; and

WHEREAS, Ramon G. Fernandez is certified by the Police Training Commission and is available to be hired as a full-time Probation Police Officer required by required by N.J.S.40A:14-122 and by 23 the New Jersey Police Training Commission.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Lawnside, County of Camden, State of New Jersey, that:

1. Ramon G. Fernandez be hired as a Probation Police Officer effective June 17, 2021 at a salary of \$47,546.00 as per the collective bargaining agreement between the Borough of Lawnside and PBA Local #30;
2. Ramon G. Fernandez will be eligible for membership in the Police Benevolent Association Intercounties Local #30 (PBA Local #30), and all of the benefits which inhere to full time members of the Lawnside Police Department who are governed by the terms and conditions of the collective bargaining agreement between the Borough of Lawnside and PBA Local #30;

WHEREAS, the Bids will be publicly opened and read immediately thereafter being mindful of social distancing practices.

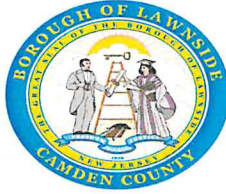

RESOLUTION AUTHORIZING THE CALENDAR YEAR 2021 “RESERVE FOR UNCOLLECTED TAXES” TO BE CALCULATED USING A THREE YEAR AVERAGE

WHEREAS, the budget appropriation “Reserve for Uncollected Taxes” (RUT) is calculated using the prior years percentage of cash collections to total Levy; and

WHEREAS, N.J.S.A. 40A:4 allows the RUT, when approved by resolution of the governing body, to be calculated using a three (3) year average of prior years percentage of cash collections; and

WHEREAS, using last year’s reduced collections rate alone would increase the amount to be raised by taxation providing unnecessary financial hardship upon the tax payers of the Borough of Lawnside.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Lawnside, County of Camden, State of New Jersey, hereby authorizes the Chief Financial Officer to use a three (3) year average of prior years percentage of cash collections for the calculations of the CY 2021 budget appropriation “Reserve for Uncollected Taxes”.

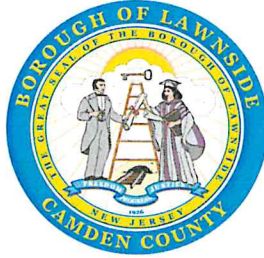

**AWARDING A 3(THREE) MONTH CONTRACT FOR SOLID WASTE AND BULKY
WASTE COLLECTION SERVICE IN THE BOROUGH OF LAWNSIDE**

WHEREAS, the Borough of Lawnside is in need of the collection, removal and disposal of trash, and garbage, to provide for the health, safety and welfare of its citizens; and

WHEREAS, the 3(three) month contract will be effective October 1, 2021 until December 31, 2021, giving such time that The Borough of Lawnside has been able to receive bids, and execute a new trash collection contract; and

WHEREAS, the Business Administrator and Borough Solicitor recommend that Mayor and Council award trash collection for a 3(three) month basis beginning October 1, 2021 until December 31, 2021 to **South Jersey Sanitation, 253 N. White Horse Pike, Hammonton, NJ 08037 at a rate of \$98.71 per ton for weekly trash collection.**

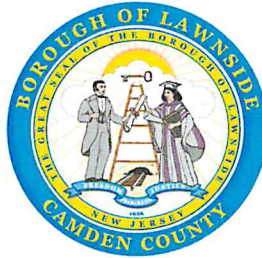
