WHEREAS, once redeemed monies are forwarded to CCMUA; and



WHEREAS, the Mayor and Council of the Borough of Lawnside, in consideration of its population, current staffing levels, resources and acute needs to maximize the Borough's efficacy in its provision of governmental services and supporting Borough operations; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Lawnside hereby adopts that the records custodian's schedule of "OPRA hours" shall run from 9am to 5pm on Monday, Tuesday and Wednesday of each week; with such hours to be advertised on the Borough of Lawnside's website and adopted Open Public Records Act request form.
